### **Right to Rent Declaration**

All occupiers aged 18 and over must provide proof of Right to Reside in the United Kingdom.

### This document must be witnessed by the landlord or agent.

No tenancy will be executed until the necessary original documentation has been provided by all prospective occupiers aged 18 or older.

This proof must be either an original document listed on the front of the application or two original documents listed below.

- A full birth or adoption certificate issued in the UK, the Channel Islands, the Isle of Man or Ireland, which includes the name(s) of at least one of the holder's parents or adoptive parents.
- Evidence (identity card, document of confirmation issued by one of HM forces, confirmation letter issued by the secretary of state of the holder's previous of current service in any of HM's UK armed forces.
- A letter from HM Prison Service or the Northern Ireland Prison Service confirming the holder's name, date of birth and that they have been released from custody
- A letter from your probation worker
- A current full or provisional photocard UK driving licence
- A letter from a UK further or higher education institution
- Benefits letter issued by HMRC, a UK Local Authority or Job Centre Plus or DWP
- A letter from your support worker or Social worker
- A letter or reference from your employer confirming employee reference and position
- Disclosure and Barring Service Certificate (criminal record check) issued within the 3 months prior to the check
